\$100 charge for additional 1/2 day High Ropes Course

*\*1/2 day High Ropes Course normally takes 2-3 hours and includes Zip Line, Giant Swing, and Leap of Faith.  
 The Low Ropes Course can be used at any time and is included in all rentals.  
 CSC will try to work within your budget. Your rental fees help to improve the facilities.*
